

## **Residential Conveyancing – Fees**

Estimates can only be provided based on the information you provide us with and on the assumption that the transaction will not prove to be substantially more complex or time-consuming than expected. If the matter proves to be complex, you will be informed by the person dealing with your matter about any additional fees likely to be charged and why. The hourly rate of the person dealing with the matter may then apply.

If the matter does not proceed to completion, work done and payments made up to that point will remain chargeable.

*Explanatory Notes*

- *Disbursements* are costs related to your matter that are payable to third parties, such as Land Registry Fees. We handle the payment of the disbursements on your behalf to ensure a smoother process.
- *Stamp Duty Land Tax* (on purchases) – this depends on the purchase price of the property and the situation, for example if you are a first time buyer or you are buying a second property. You can calculate the amount you will need to pay by using the HMRC's website or if the property is located in Wales by using the Welsh Revenue Authority's website.
